

## Terms & Conditions

LiveLighter® Boost Your Budget Facebook competition Terms and Conditions June 2023.

By entering the LiveLighter® Boost Your Budget Facebook Competition (the Competition), you agree to be bound by these Terms and Conditions. Information about how to enter forms part of these Terms and Conditions.

The Promoter of the Competition is the LiveLighter® program. The LiveLighter® program is managed by Cancer Council Western Australia Inc (ABN 15 190 821 561) under contract with the Western Australian Department of Health. This promotion is in no way sponsored, endorsed or administered by, or associated with Facebook.

### *Prize*

The prize: Eight (8) x \$250 eGiftcards to grocery stores. Total prize pool is eight (8) grocery store eGiftcards with a total value of \$2000. The eGiftcards vouchers will be from agreed grocery stores between each winner and the LiveLighter® program. If the prize is unavailable, the Promoter reserves the right to substitute another item for the prize, in its sole discretion, of equal or higher value. The prize is not transferable or redeemable for cash.

### *Who can enter?*

The Competition is free and open to persons aged 18 years and over who reside in Western Australia. Employees and volunteers of the Promoter and their immediate family members are ineligible to enter.

### *How to enter*

The Competition commences at 9am AWST on Monday 12<sup>th</sup> June 2023 and closes 10am AWST on Friday 23<sup>rd</sup> June 2023. Open to WA residents aged 18 years and over. Entries received after that time or not completed in accordance with these Terms and Conditions will not be eligible to win a prize.

To enter, post a 'comment' in response to the question "Tell us best tip to eat healthy whilst saving on your food shopping" on the competition post promoted by the official LiveLighter® Facebook page. The comment must be posted on the competition post itself (i.e. not shares of the post) to be considered for the prize draw. Feel free to include pictures to support your comment. LiveLighter® will only consider the submission of tips that promote healthy eating.

Maximum three (3) entries per person. One person cannot win multiple times.

Valid entries will be shortlisted by the Promoter and subject to a vote by staff of the LiveLighter® program. Where the same tips are submitted, the first entry received (as per the Facebook timestamp) will be the one considered.
