

## **LiveLighter® Western Australia Dish Dash Competition Terms and Conditions April 2026**

By entering the LiveLighter® Dish Dash Competition (the Competition), you agree to be bound by these Terms and Conditions. Information about how to enter the Competition forms part of these Terms and Conditions.

### **The Promoter**

The promoter of the Competition is Cancer Council Western Australia Inc (ABN 15 190 821 561) (the Promoter), as the implementing body for the LiveLighter® service and campaign in Western Australia, under contract with the Western Australian Department of Health.

### **The prize**

One of twelve (12) x \$200 gift cards to a grocery store of the Promoter's choosing. One x \$200 gift card will be drawn each week for twelve (12) weeks. The total prize pool is twelve (12) gift cards with a total value of \$2400. The gift cards will be from agreed stores between each winner and the Promoter.

If the prize is unavailable, the Promoter reserves the right to substitute another item for the prize, in its sole discretion, of equal or higher value. The prize is not transferable or redeemable for cash.

The Competition is free and open to persons aged 18 years and over who reside in Western Australia. Employees and volunteers of the Promoter's Food and Movement Programs Team and their immediate family members are ineligible to enter.

### **How to enter**

The Competition commences at 3:00 PM AWST on Thursday 2 April 2026 and closes at 9:30 AM AWST on Thursday 9 July 2026.

To enter, head to the official competition page on the LiveLighter® website (<https://livelighter.com.au/habits>) and register to do the "Dish Dash" by completing the form and verifying your email address. Each entry will be included in a single weekly prize draw.

Entries received after the closing time or not completed in accordance with these Terms and Conditions will not be eligible to win a prize. The Promoter has no responsibility to accept late, lost or misdirected entries.

Maximum one (1) entry per person. This is a game of chance.

### **Drawing the winner**
